

A merger of equals 01/01/2018: strategic considerations

- Strengthening economic region
 - Top 3 port added value
 - Top 10 port in terms of tonnage
 - Increasing brand awareness
 - Increasing employment
 - Decreasing dependence
 - Stronger lobbying power
 - Possibility of a hub for surrounding (world) ports
 - Increased financial strength
 - Stronger organisational
- > Merger on parity = realistic and defensible at all levels: governance, organisational and financial




Eight programmes to further develop as European port



European and cross border cooperation between ports & energy

- **Mid-Sized European Ports:** sustainability, energy transition, digitalisation and the European transport network
- **Unite to secure a sustainable future for industry in Europe:** Port of Rotterdam (no. 1 in EU), Port of Antwerp-Bruges (no. 2 in EU), Duisburger Hafen AG and North Sea Port – *opinion article*
- **Port of Gotenborg:** Green corridor
- **European Sea Ports Organisation (ESPO):** represents port authorities, port associations and port administrations of the seaports of 21 Member States of the European Union and Norway at EU political level - *vice-president (Energy)*



European and cross border cooperation between ports & energy

- **Developing cross border hydrogen hub:**
 - Collaboration Dutch and Belgian gas company
 - European hub import, production, export
 - Pipeline network connecting European backbone

- **Developing pipelines for CO2 transport:**
 - Shareholder of Pipelink, a company of Port of Antwerp-Bruges
 - Carbon capture & storage & utilisation (CCUS)
 - 2030: 50% emission reduction
 - 2050: CO2 & climate neutral economy & port
